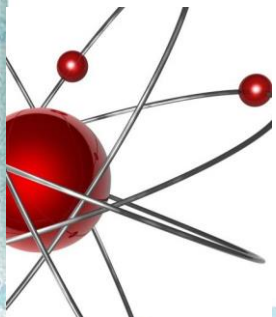

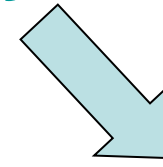

CONCERT Calls

The need for an overarching multidisciplinary long term Roadmap for research

- **Collect from multiple sources, analyse and validate elements for long term R&D objectives**
- **Provide the R&D community and its stakeholders a stable (but updatable) vision of the recommended pathway to these objectives**
- **Facilitate continuity between the successive EURATOM work programmes with respect to Radiation Protection, and optimize resource allocation**
- **Develop a reliable mechanism for regular updating of the long term Roadmap**

Boundary conditions: The long term Roadmap should be:

- **In line with general H2020 goals**
- **In line with CONCERT EJP objectives**
- **Based on state of the art science and experience return**
- **Balancing fundamental and applied research**
- **Inviting multidisciplinary**
- **Taking into account the existing resource allocation at national and Euratom levels, and the need for sustainability of the research effort**
- **Taking into account needs expressed by all parties concerned**

Expected Deliverables and Milestones

- Year One activity:
 - Contribute to the elaboration of the first RTD Call
 - propose a strategy for the development of a long-term roadmap for Radiation protection research, leading to:
- **D3.3: M24 (June 2017): First Joint roadmap draft**
- **M3.3: M24 First Joint Roadmap**
- **M3.4: M 36 (June 2018): validation of first Roadmap**
- **D3.7: M48 (June 2019): Second joint Roadmap**
- **M3.3: M48 Second Joint Roadmap**
- **M3.4: M 60 (June 2020): validation of second Roadmap**

Task 3.3: proposed work process

- **Sub task 3.3.1: budget partitionning recommendation for the first call**
 - **Set up a task group out of MENA, which will work by correspondence and meet twice: once during the MELODI Workshop week (november 2015); once to finalize a recommendation (in time for the CONCERT MB needs, possibly just before the MB)**
 - **Analyze historical data available through OPERRA in the light of priorities developed by WP3.2**
 - **Prepare a partitionning table to be proposed to CONCERT MB**

Task 3.3: proposed work process

Subtask 3.3.2: develop and maintain a long term roadmap including resource allocation recommendations

- **Task to start after the work on first RTD call is finished (early 2016)**
- **Adjust the TaskGroup as required for this new objective**
- **Hold a one day seminar (Feb /March 2016?) to establish work methodology, on the basis of a working paper to be developed by the Task Lead**
- **Consult MENA on the proposed methodology (spring 2016)**
- **Develop a first draft Long Term Roadmap for presentation at the Oxford radiation protection researchweek, and collect comments**
- **Submit to CONCERT MB a revised draft feb 2017 (meeting before MB)**
- **Finalise CONCERT deliverable D 3.3 for may 2017 (meeting before MB)**
