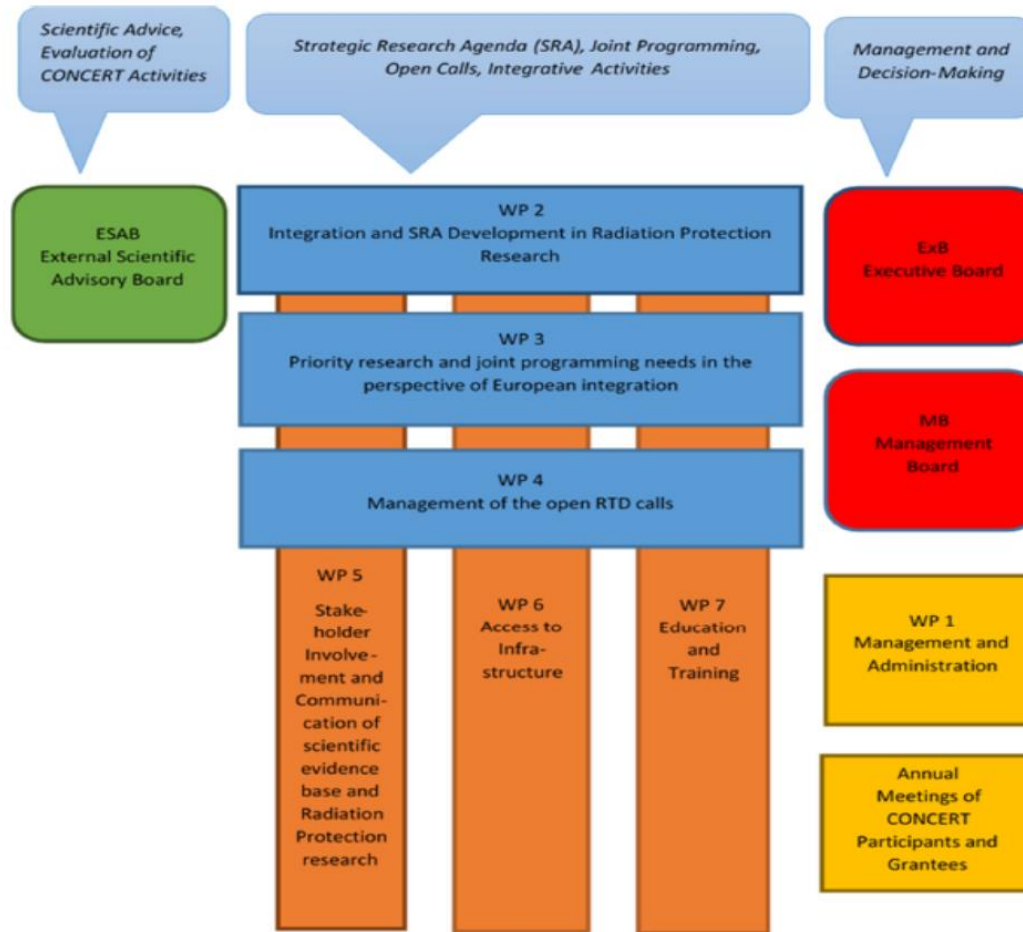


Aims of WP5

Development of website information

- Aim to provide reliable and trusted information for a wide audience on radiation risk and radiation protection
- Topics to include will be informed by stakeholder panel and eSurvey
- Start small and grow over time
- Utilise existing web resources where available
- Also develop more technical information on implementation of radiation protection standards
